# Request for a leave of absence during Term Time

Academic Year 2024-25

Dear Parents/Carers

I wanted to **remind** all families of the school policy in regard to attendance (which can be found on the school website). The law does not grant parents an automatic right to take their child out of school during term time. The Department for Education allows a Head Teacher the discretion to consider authorising a leave of absence in term time only in "exceptional circumstances".

If you consider that your request for a leave of absence is 'exceptional' you will need to complete the form below. If the leave of absence is not considered to be an exceptional circumstance, and you nevertheless take your child out of school for the leave of absence this <u>will be recorded as unauthorised leave.</u>

In the case of an unauthorised leave of absence the Education Welfare Service may be notified of the absence taken and a Penalty Notice may be issued. Please note that such a Penalty is issued to each parent for each child taken out of school. On the first occasion, an issued Penalty Notice in respect of your child, on or after 19th August 2024, will be charged at £160 if paid within 28 days. This amount will be reduced to £80 if paid within 21 days. Thereafter, if the Penalty remains unpaid this may lead to prosecution through the Magistrates' Court.

All leave of absence requests must be completed on the attached form, letters or emails will not be accepted. This should be returned to the school at least 14 days before the start of the leave of absence. All requests must be made prior to the leave being taken. **Leave cannot be authorised retrospectively.** 

Thank you for supporting our efforts to raise attendance and attainment at our school.
